Proposed Changes to Chamber By-Laws to add Membership Director as an Officer

4/19/2021

1. Add to Article V, Section I, as Paragraph E, the following Membership Director duties:

“Membership Director shall lead efforts in planning an annual membership drive, promote membership throughout the year, maintain membership records to include an electronic document of the names, emails, and addresses of all members, and periodically provide the updated member list to the website administrator for publication.”

2. Revise Article V, Section 1, Paragraph C, to delete the following phrase from the secretary’s duties:

“keep a register of the names and addresses of all members”

3. In Article V, Section 1, change current Paragraph E to make it Paragraph F (i.e., move the paragraph about the Manager to the bottom of Article V, Section 1)
